Women Board Members: Last year FinTech Nation co-authored a thought leadership report with Russell Reynolds Associates, and Singapore FinTech Association on understanding the diversity metrics in ASEAN region. The focus was specifically on women representation at Board, Founder and Investor level within FinTech and startup landscape. And we saw that on an average, women only represent 13% of the boards in ASEAN fintech landscape. While the present looks certainly dire, the community has been implementing multiple initiatives to identify and equip the leaders of tomorrow. And under FinTech65 2024, we wanted to use this platform to shine the spotlight on these wonderful women who are truly leading by example, and paving the way forward.



Emerging Investors: In the startup circle, one seems to always know the Principal Investor / Director of the VC, PE firms. At FinTech Nation, we believe that it is equally important to bring the focus on the young and upcoming investors in these teams. All the individuals you see as part of this list have been nominated by their peers and teams for not just doing their work, but for pushing the boundaries, and excelling at it.

Fintech Nation™ was founded as a grassroots platform by Varun Mittal to bring together the fintech community, regulators, investors, startups, and corporations. It started with an initial mission of developing the local fintech community from 2015, and then graduating to the next level in 2020 with the development of the Fintech Nation book and other community initiatives.

Empowering a prosperous future for all, Fintech Nation, as a development institution, envisions a world where financial access, digital innovation, and meaningful outcomes are within reach for everyone. We continuously endeavour to support startups, angel investors, financial institutions, practitioners, and policymakers. And we hope to achieve this through our three key pillars: investment platform, think tank, and ecosystem builder.



Investment Platform: At Fintech Nation, we understand that capital is the lifeblood of startups, fueling their journey towards growth and success. As a premier investment platform, we specialise in empowering entrepreneurs with the capital they need to scale their ventures and realise their dreams. Our investment platform executes along two key pillars of origination and orchestration.



Think Tank: The Think Tank aims to use advocacy and access as its two pillars to bring startups, financial institutions, and investors' aspirations and motivations to policymakers, regulators, and other official development institutions. Fintech Nation developed the concept of Singanomics™, which chronicled the unique Singaporean model of development that brings together the public and private sectors to achieve holistic progress and development for the Fintech Nation.



Ecosystem Builder: Fintech Nation originated as a grassroots ecosystem player, with its founder, Varun, being the founder of Singapore Fintech Association and ASEAN Fintech Network. He has built and operated multiple whatsapp community networks over the years and as Fintech Nation evolved through the years, there are two key objectives of Fintech Nation as an ecosystem builder are enabling Recognition and Relationships.

Together, we aspire to build an open, inclusive, and transformative Fintech Nation - where everyone has the tools and support they need to thrive in a rapidly changing world.



Fintech65™ is a Talent Initiative under the Ecosystem Builder pillar of the Fintech Nation to identify and recognise emerging and proven leaders across different categories like startups, corporate, product management and venture capital in Singapore. Fintech 65 develops annual lists of 65 leaders curated by leaders from industry and academic institutions with an open nomination process for grassroots participation. The platform enables peer-to-peer learning and mentorship for young talents from experienced ones.

In 2023 and 2022, more than 500+ individuals were nominated, and 250+ were recognised across categories.

In 2022, the Fintech 65 theme was focused on identifying leaders across five categories: Emerging FinTech Founders, Young Leaders in FinTech (aged 30 and younger), Women in FinTech, Women in Corporate and Women Investors.

In 2023, it focused on Regulatory and Compliance, Artificial Intelligence & Data Analytics (Women), ESG and Sustainability and Web3 & Blockchain.

Fintech Nation is thrilled to honour these trailblazers who have demonstrated their vision, leadership, and innovation in advancing fintech in Singapore. Fintech Nation uses the following set of judging criteria to identify the top 65 individuals:

- 1. **Impact**: The extent of the individual's impact on the fintech industry in Singapore and beyond
- 2. **Innovation**: The individual's ability to innovate and create new solutions in the fintech space
- 3. **Builder/Founders**: they have built products; they can be technical, they can be commercial, and they can build teams/operations to go from an idea to something real
- 4. **Leadership**: The individual's leadership qualities and the ability to inspire and guide teams
- 5. **Industry Recognition**: The individual's recognition and awards within the fintech industry in Singapore and beyond
- 6. **Contribution to Community**: The individual's contribution to the fintech community in Singapore through mentoring, education, or other forms of community engagement.

Fintech Nation partners with the Singapore Fintech Association and Elevandi (organiser of the Singapore Fintech Festival) as community partners for the Fintech65™ platform.

Once again, we are proud to recognise and honour these exceptional individuals who have played a pivotal role in shaping the fintech landscape in Singapore, often creating and sometimes bringing international standards to the forefront.
